# APPLICATION FOR MEMBERSHIP

## EXPLANATORY NOTES

### Eligibility

Any company, partnership or sole proprietor, engaged in the manufacture of iron and steel products is eligible to become a member of the Malaysian Iron and Steel Industry Federation.

### Entrance Fee and Subscription

An Entrance Fee of RM250 and an Annual Subscription (*payable in advance*) will be levied, depending on the issued capital, in accordance with the following scale:-

| Issued Capital  | Annual Subscription |
|---|---------------------|
| RM5 million and below                                 | RM1,500             |
| More than RM5 million,<br>less than RM10 million      | RM2,500             |
| RM10 million and above<br>but less than RM40 million  | RM3,500             |
| RM40 million and above<br>but less than RM100 million | RM6,000             |
| RM100 million and above                               | RM12,000            |
