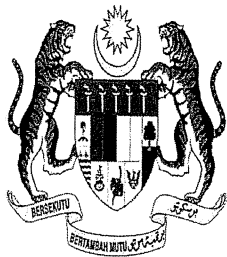

NOTICE OF EXTENSION OF TIME PERIOD FOR MAKING
PRELIMINARY DETERMINATION

(AD 02/24)

FOLLOWING the publication of the Notice of Initiation of Anti-Dumping Duty Investigation with regard to the Imports of Flat-Rolled Products of Iron or Non-Alloy Steel of a Width of 600mm or More, Clad, Plated or Coated With Tin (Electrolytic Tinplate or Tinplate) Originating or Exported from the People's Republic of China, the Republic of India, Japan and the Republic of Korea in P.U. (B) 313/2024 on 14 August 2024, the Government, pursuant to subregulation 10(2) of the Countervailing and Anti-Dumping Duties Regulations 1994 [*P.U. (A) 233/1994*], extends the time period of anti-dumping duty investigation by an additional thirty days from 13 December 2024 to 11 January 2025 for making the preliminary determination in the case of the anti-dumping duty investigation with regard to the imports of flat-rolled products of iron or non-alloy steel of a width of 600mm or more, clad, plated or coated with tin (electrolytic tinplate or tinplate) originating or exported from the People's Republic of China, the Republic of India, Japan and the Republic of Korea.
